

CRDF GLOBAL REQUEST FOR PROPOSAL or INFORMATION

Deadline: November 30, 2022

Summary:

CRDF Global is seeking multiple subject matter experts to support an international study-tour to the United States focused on research security. The goal of this study tour fellowship program is to build capacity at partner universities to protect their research and technology from diversion and exploitation. Experts will develop and deliver presentations and roundtable discussions for at least 8 fellows from international universities from advanced science and technology fields such as synthetic biology, biotechnology, artificial intelligence, and quantum computing. The study tour will last for one week and will take place at Harvard University in April 2023. All of the fellows will be senior researchers, compliance officers, or departmental leadership from advanced technological and research universities in Morocco.

Scope:

The experts would contribute to a nine-month-long fellowship program by participating in an introductory online seminar, delivering several presentations during the week-long study tour, being available for one-on-one sessions with all fellows during the study tour, and being the assigned mentor to at least two of the fellows in the several months that follow the study tour during which the fellows will be conducting their own research and preparing their own community event on research security at universities and nonproliferation. Experts will be expected to contribute introductory remarks and attend the preliminary online seminar. The subject matter that the experts present on during the study tour may have focuses such as: compliance, cyber security at universities, research collaboration due diligence, red flag review, and laboratory security. Experts will attend the study tour in-person if geography allows or CRDF Global will facilitate their joining the event remotely via Zoom. The experts will be agree upon at least two of the fellows to act as the primary substantive point of contact and mentor as the fellows develop their own research and conduct their own training, roundtable, or other type of event on the subject of nonproliferation and research security.

Proposed areas for experts to address include:

- Understanding threats to research and technology
- Balancing security threats against research sector concerns
- Reducing employee vulnerability
- Cyber security in academia
- Laboratory security

Tasks and Deliverables:

The selected experts will complete the below tasks.

- 1. Attend introductory webinar
 - a. Two-hours in length
 - b. Experts will deliver introductory remarks in coordination with one another
- 2. Prepare and deliver presentations during the week-long study tour



- a. The presentations may include subject matter presentations, round table discussions, simulations, and hands-on exercises.
- 3. Regular meetings with selected grant fellows
 - a. At least two meetings per month to be arranged with the fellow, email communication, and general support.

* All contracted experts will be required to be in regular communication with CRDF Global as determined by the contract and all contracted experts will be expected to complete final reports after the completion of all other tasks as well as debrief call(s).

Contractor Requirements:

A successful proposal must highlight a strong understanding of some of the following topics:

- Emerging technologies such as: biotechnology, artificial intelligence, quantum computing, and synthetic biology.
- Proliferator state strategies targeting research institutions
- Illicit proliferator state cyber and technology transfer activity
- University compliance best practices
- Cybersecurity and cyber hygiene

While not required, preferences include:

- Connections to emerging tech and advanced technological institutions in Morocco.
- Familiarity with remote conferences
- Ability to communicate in French or Arabic

Proposal Requirements:

Each proposal must include:

- Statement of Interest and Technical Capabilities
- Cost proposal-If you intend to propose a fixed cost, please also include your hourly rate.
- CV(s); if the tasks will be completed by a team, all team members' CVs should be submitted as one document
- List of recent experience in the RFP Subject Matter area and applicable references/past performance
- Any Small or Disadvantaged Business Designations (Veteran Owned, HUB Zone, Women Owned, Disadvantaged Businesses)
