

## CRDF GLOBAL REQUEST FOR PROPOSAL (RFP) Subject Matter Experts on Chemical Security

Deadline: October 3, 2022

#### **Summary:**

CRDF Global is seeking subject matter experts (SMEs) with experience developing and delivering instruction to university faculty and graduate students on best practices in chemical security in university/research laboratories. This training course will address high-risk material theft and misuse in Moroccan and Tunisian academic institutions. Participants will be able to prevent, identify, and mitigate insider threats by employing best practices for personnel screening, recognizing indicators of radicalization, and detecting and deterring chemical theft. The course will strengthen chemical security practices in North African universities and build capacity to detect and deter threats to high-risk chemical materials.

#### Scope of Work:

This project will consist of an asynchronous online course with at least six separate thirty-minute modules and one two-hour webinar which will bring academia participants from Tunisia and Morocco together.

The subject matter expert (SME) hereby referred to as "The Contractor" will provide course materials for the training series and present the course materials during the training as an SME. The Contractor will complete and submit to CRDF Global a post-event report summarizing the technical outcomes of the conference and recommending follow-on activities for chemical incident prevention and response. The Contractor will communicate regularly with CRDF Global through phone calls and emails as needed.

## Task One: Project Coordination

The contractor will coordinate with CRDF Global by participating in conference calls, as needed.

#### Task Two: Training Materials – Agenda and Presentation Development

In coordination with the project team, to include CRDF Global, the Contractor will contribute to the development of a final agenda and up to three presentations covering the topics of Insider Threat Mitigation, Suspicious Activity Reporting, Personnel Screening Best Practices, Identifying Signs of Radicalization, and Detecting and Deterring Chemical Theft. The Contractor will coordinate with CRDF Global and other Contractors to ensure the workshop meets CTR's goals.

## Task Two Deliverables:

- Set of materials, tailored to a Moroccan and Tunisian audience, to include:
  - Final agenda, to be developed in coordination with project team
  - Up to three (3) presentations

Level of Effort: Not to exceed 45 hours without written pre-approval from CRDF Global.

## Task Three: Video Modules

The contractor will develop three modules for the online course on the topics of Insider Threat Mitigation, Suspicious Activity Reporting, Personnel Screening Best Practices, Identifying Signs of Radicalization, and Detecting and Deterring Chemical Theft. The contractor will video tape these lessons to be uploaded to the online course.



## **Task Three Deliverables:**

• Three video modules

Level of Effort: Not to exceed 5 hours without written pre-approval from CRDF Global.

# Task Four: Implementation

The contractor will lead his portion of the one webinar session for up to 90 university faculty and administrators from Morocco and Tunisia and will attend in full. The webinar is expected to consist of two hours, focused on providing presentations and answering participants' questions, if needed. The consultant will participate in test sessions lasting 30 minutes prior to each webinar session to ensure video/audio/text capabilities function correctly and will stay online for any extended Q&A and debrief activities for approximately 30 minutes following the end of each session.

# **Task Four Deliverables:**

• Participate in and facilitate the one-day, two-hour webinar, 30 minute test-session, and 30 minute debrief

Level of Effort: Not to exceed 3 hours per SME without written pre-approval from CRDF Global.

# Task Five: Debrief and Project Close-out

The Contractor will complete and submit to CRDF Global a brief after-action report, using CRDF Global's reporting template, summarizing technical outcomes of the activity and any recommended follow-on activities for preventing chemical attacks and insider threats in high-risk intuitions in North Africa.

## **Task Five Deliverables:**

- Final report (within five days of the completion of the webinar)
- Final invoice (within two weeks of the completion of the webinar)

Level of Effort: Not to exceed 4 hours without written pre-approval from CRDF Global.

## **Contractor Requirements:**

The contractor will have experience developing and delivering trainings on chemical security and additional experience assisting in or leading the chemical security trainings to university faculty. The contractor will have a demonstrated capability to conduct training and mentoring in one or more of the following areas:

- Insider Threat Mitigation
- Suspicious Activity Reporting
- Personnel Screening Best Practices
- Identifying Signs of Radicalization
- Detecting and Deterring Chemical Theft

Subject Matter Experts shall have:

- 1. Technical Experience: At least 7-10 years of relevant professional experience. Applicable experience can include a combination of the below:
  - Chemical security; particularly consulting on university/research laboratory chemical security practices
  - Experience leading training events on chemical security in university/research laboratories
  - Experience developing and leading table-top or interactive exercises on chemical security in university/research laboratories

- Experience leading or consulting on chemical security in university/research laboratories
- Experience engaging university students and faculty and/or laboratory staff in regions including South Asia, Southeast Asia, Sub-Saharan Africa, Middle East and North Africa, or Latin America
- 2. Past Performance: Evidence of successful implementation of projects with similar or relevant scopes that were funded by external entities, including non-governmental organizations and international donors. Supporting materials that demonstrate timely communication, completion of tasks, and submission of deliverables should also be referenced.

## **Contractor Selection Criteria:**

CRDF Global will select contractors that provide the best value in terms of overall price and experience. The contractor should have proven international experience working with academic or chemical sector actors (e.g. university students and faculty, chemical laboratory personnel).
