

CRDF GLOBAL REQUEST FOR PROPOSAL Security Culture Hackathon for Innovation Hubs, Incubators, and Women in Tech

Deadline: July 10, 2023

Summary:

CRDF Global is seeking subject matter expert(s) (SMEs) to engage and educate global audiences. The expert(s) will work on deliverables relating to building a culture of security in the private sector. These deliverables will include the development of an online asynchronous course and four hybrid hackathons, which will take place at local incubator hubs in several countries.

Scope:

The expert(s) will design and develop an asynchronous course to counter misuse and raise awareness of emerging technologies with potential weapons of mass destruction (WMD)-related applications by state and non-state actors. The audience for this course will be individuals in the private sector (particularly in start-ups, innovation hubs, and incubator spaces) in various countries globally. This asynchronous course should train key stakeholders on how to develop and foster a culture of security.

Selected SME(s) will also remotely support four virtual hackathons as experts that teams can reach out to for insights. The hackathons, logistically organized by the CRDF Global team and local partners, will provide participants with an opportunity to develop concepts that will instill a culture of security in incubators and innovation hubs, which could include ideas for training apps, cybersecurity measures, or innovative ways to increase awareness of risks or protect technology. Selected SME(s) will assist in the judging of ideas developed by the hackathon participants to help select the best and most feasible identified solutions. The top two solutions will be awarded a grant from CRDF Global to implement their concept. The SME(s) will have the opportunity to provide virtual support to the selected grantees to ensure successful projects.

Tasks and Deliverables:

CRDF Global is seeking SME(s) who can implement a portion of the deliverables best suited to the SME(s) capabilities and past experience or the whole project. Proposals supporting the entire project are preferred, but CRDF Global will also consider proposals that, for example, may only include developing and co-leading a portion of trainings. CRDF Global will consider proposals from both individuals and institutional teams that can support the following tasks and deliverables:

- 1. Design and develop asynchronous course curriculum, agendas, presentations, and pre-recorded videos prior to relevant events (anticipated development completion to be July 2023);
- 2. Design, develop, and lead an asynchronous course on creating a security culture in innovation hubs (anticipated development completion to be September 2023);
- 3. Attend weekly coordination calls as needed until the end of the project (anticipated March 2024);
- 4. Support and lead hybrid (remote and in-person) hackathons to provide participants with an opportunity to develop concepts that will instill a culture of security in incubators and innovation hubs (hackathons anticipated to be hosted once a month August through November 2023);
- 5. Judge the nonproliferation impact and feasibility of participant concepts to select grantees;
- 6. Work with grantees to provide virtual support for their selected concepts to ensure success; and



7. Submit After Action Reports which summarize observations, successes, lessons learned, and recommendations for future programming based on the trainings.

Required Contractor Requirements:

- 1. Experience working with or advising international innovators or entrepreneurs from businesses, incubator spaces, and innovation hubs.
- 2. Knowledge of the following subject matter areas:
 - a. Educating global audiences on securing emerging technologies.
 - b. Trends and threats related to emerging technologies/security.

Preferred Contractor Requirements:

- 3. At least five years of relevant experience conducting research, delivering briefings or trainings, and/or implementing policy or capacity-building activities related to emerging technology security field.
- 4. Knowledge of the following subject matter areas:
 - a. Building a culture of security.
 - b. Policy best practices of emerging technology to mitigate WMD-related risks.
- 5. An understanding of regional political and cultural dynamics in Europe, East Asia Pacific, Sub-Saharan Africa, or the Western Hemisphere.

Proposal Requirements:

Each proposal must include:

- 2. Cost proposal
- 3. CV(s)
- 4. List of recent experience in the RFP Subject Matter area and applicable references/past performance
- 5. Any Small or Disadvantaged Business Designations (Veteran Owned, HUB Zone, Women Owned, Disadvantaged Businesses)
- 6. <u>NAICS Codes</u>: 541620 Environmental Consulting Services- Small Business Threshold \$15 million 541690 Other Scientific and Technical Consulting Services – \$15 million

Contractor Selection Criteria:

CRDF Global will select the contractor that provides the best value in terms of overall price, knowledge, experience, and availability.

The SME(s) must demonstrate through their proposals:

- 1. Their proven experience in the subject matter expertise
- 2. Their qualification based on the preferred requirements as listed in the Contractor Requirements Section
- 3. Their capability to fulfill the assignment described in the Scope, Tasks, and Deliverables section.



Experience working with/in diverse audiences and geographies is preferred, as is experience working in virtual environments.
