Subject Matter Experts on Enhancing Chemical Security Awareness in Bangladesh Academia

Project Overview:

CRDF Global will support a three-day Training of Trainers (TOT) program in Bangladesh for 20 professors from different public and private universities that offer undergraduate and graduate programs in chemistry. The training will focus on the role of academia in chemical security; integrated systems for chemical safety and security; regulations, standards, codes, and policies related to the safety and security of chemicals; risk management systems; risk reduction tools for chemical control; and dual nature chemicals and associated threats. The training will enhance the capacity of Bangladeshi academics to effectively educate their peers and students on chemical security best practices, thereby mitigating the risks associated with the acquisition of weaponizable chemical assets by violent non-state actors in Bangladesh.

Scope of Work:

The subject matter expert (SME), hereby referred to as "The Contractor" will develop course materials for the training series, present the course materials, and lead discussion sessions and interactive exercises during the training which is scheduled to occur October 25-27, 2023. The Contractor will be awarded a contract (to include labor, economy flight, lodging, and per diem) provided following the completion and submission of the tasks and their deliverables outlined below:

Period of Performance: August 25 – November 3, 2023

Task One: Project Coordination

The Contractor will participate in planning calls, meetings, and e-mails with CRDF Global & other Subject Matter Experts (SMEs) prior to the training sessions to develop the agenda. CRDF Global will agree on a mutual time with the contractor for meeting times and frequencies.

Task Two: Materials Development

The Contractor will contribute to the development of the training materials, interactive exercises, and develop one or more sessions and/or exercises prior to the training. The Contractor will coordinate with CRDF Global and another contractor to ensure the training meets CTR's goals.

Deliverable:

a. Four or more presentations, exercises, and/or training materials (slide decks, presentations, supplemental materials, exercises etc.) prior to the event. Submit the presentations, exercises, and/or training materials to CRDF Global for review and translation within the time frame agreed upon by the project team.



Task Three: Travel and Logistical Arrangements

The Contractor will take an economy class flight to Dhaka, Bangladesh for the training. CRDF Global will support flight, lodging, and ground transportation in Bangladesh. CRDF Global will refund any ground transportation costs and provide per-diem.

Task Four: Training Implementation

The Contractor will facilitate discussions at the training on assigned topics, present their developed presentations and training materials, and participate in brief speaker/organization meetings on the day prior to the conference as well as daily at the conclusion of the training.

Task Two deliverables:

- a. Present at the training; and
- b. Moderate break-out sessions as agreed upon during planning calls or noted in the agenda.
- c. Facilitation of discussions with participants and SMEs alike.
- d. Delivery of table-top exercises or activities.

Task Five: Training Close-out

The Contractor will complete and submit to CRDF Global a post-training report summarizing the technical outcomes of the training, recommendations for follow-on activities, and action planning for enhancing chemical security awareness in academic institutions in Bangladesh.

Deliverable:

- a. Technical trip report on the training implementation and related outcomes, including followon activities/recommendations for chemical security awareness in academia in Bangladesh to be completed and submitted within seven days of the training end date.
- b. Submit final invoice to CRDF Global within 20 days after training is completed.

Contractor Requirements:

The contractor will have experience developing and delivering training on chemical security and additional experience assisting in or leading the chemical security training to industry, regulatory, and/or university audiences/faculty. The contractor will have a demonstrated capability to conduct training and mentoring in one or more of the following areas:

- Role of academia in chemical security
- Integrated systems for chemical safety and security regulations, standards, codes & policies
- Risk management systems
- Risk reduction tools for chemical control and dual nature chemicals

Subject Matter Experts shall have:



- 1. Technical Experience: At least 7-10 years of relevant professional experience. Applicable experience can include a combination of the below:
 - Knowledge of Chemical security: Demonstrated understanding of chemical security principles and best practices, with a focus on consulting in university and research laboratory environments.
 - Training Event Leadership: Proven experience in leading training events, workshops, or seminars with an international audience, including academia professionals.
 - Table-top or Interactive Exercise Development: Hands-on experience in designing and facilitating table-top or interactive exercises specifically related to chemical security in university and research laboratory settings.
 - Experience engaging university students and faculty and/or laboratory staff in regions including South Asia, Southeast Asia, Sub-Saharan Africa, Middle East and North Africa, or Latin America

Contractor Selection Criteria:

CRDF Global will select contractors that provide the best value in terms of overall price and experience. The contractor should have proven international experience working with academic or chemical sector actors (e.g. university students and faculty, chemical laboratory personnel).
