

CRDF GLOBAL REQUEST FOR QUOTE

Subject Matter Expert(s) for development and delivery of the trainings on Promoting Nonproliferation Norms and Countering Nonproliferation Disinformation Through Policy and Partnership

Deadline: March 31, 2024

Summary:

CRDF Global is seeking Subject Matter Experts with experience developing and delivering trainings that target development of strategies to counter disinformation that undermines nonproliferation norms and identify opportunities to strengthen policy development; provide opportunities to inoculate civil society against the Russian attacks which endanger our partners and their work; aid to identify regional security challenges and policy objectives to support negotiation and development of agreements to inform future nonproliferation policy implementation.

CRDF Global will implement one two-day in-person training in Jakarta, Indonesia tentatively scheduled in May 2024 for at least 25 representatives from the government, civil society, nonproliferation experts, policymakers, and public sector stakeholders from Indonesia, Malaysia, and the Philippines.

Scope:

The contractor will deliver and lead one two-day in-person training for at least 25 representatives including government, civil society, nonproliferation experts, policymakers, and public sector stakeholders from Indonesia, Malaysia, and the Philippines.

The two-day training will involve multiple formats and training methods including case studies, presentations, and tabletop exercises. The Contractor will present case studies of malign influence campaigns that seek to discredit international nonproliferation norms, such as possibly the targeted Russian disinformation campaigns surrounding US-supported laboratories in Ukraine, the Caucasus, and Central Asia, among others. CRDF Global will provide actionable next steps for EAP partners to develop strategic communications strategies to counter nonproliferation disinformation and deter state from acquiring CBR materials. The workshop will culminate with a tabletop exercise during which all participants will be prompted to identify regional security challenges and policy objectives to support negotiation and development of agreements to inform future nonproliferation policy implementation.

Tasks and Deliverables:

Task 1: Engagement Preparation and Content Development

The Contractor will develop detailed training agendas tailored to the region represented, to include learning objectives for each session, supplemental training materials, such as a fact sheet on available open-source resources, presentation slide decks for each session, and the development of an interactive exercise.

The Contractor will also contribute to a pre- and post- training survey to be distributed by CRDF Global to training participants and to CRDF Global developed training certificate with a signature. All materials developed by the Contractor are to be submitted to CRDF Global for DOS CTR review at least 4 weeks prior to the agreed upon training date.

Task 2: Participant Outreach and Selection

The Contractor will aid in the development of outreach material for the event registration website to include a detailed outline that specifies the event and discussion topics, SME and/or speaker biographies with professional headshots, and a summary of learning objectives to be delivered to CRDF Global on a mutually agreed upon date. Once a registration list



of participants is created, the Contractor will aid in the selection of participants to give recommendations of who is best suited to attend.

Task 3: In-Person Trainings Implementation

The Contactor will deliver and lead one two-day in-person training in Jakarta, Indonesia tentatively scheduled for May 2024. Each training day will last at least 6 hours long. During the training, The Contractor will utilize presentation slide decks accompanied with interactive elements such as a Q&A and case study simulations. The workshop will culminate with a tabletop exercise during which all participants will be prompted to identify regional security challenges and policy objectives to support negotiation and development of agreements to inform future nonproliferation policy implementation.

Task 4: Communication and Reporting

The Contractor will participate in weekly one-hour long planning calls with CRDF Global to discuss programmatic updates, relevant conversations with ISN/CTR staff, and accommodate shifts in project implementation. CRDF Global and the Contractor will identify a mutually agreed upon day and time for all parties to convene. Following the training, the Contractor will provide an After Action (AAR) subject-matter expert report (template will be provided by CRDF Global) to describe audience feedback during the webinar, provide an assessment of knowledge gained by the participants, detail the lessons learned, as well as provide recommendations for follow-on activities. SME report is due to CRDF Global no later than 10 business days following the workshop.

- 1) Prior experience developing and implementing curriculum at an advanced level with a focus on Nonproliferation Norms and Countering Nonproliferation Disinformation in Southeast Asia.
- 2) Prior experience working with the government, civil society, nonproliferation experts, policymakers, and public sector stakeholders on topics such as nonproliferation, disinformation campaigns related to nonproliferation, false claims about malicious activities that undermine public trust, Russian Federation's attempts to disrupt nonproliferation norms, Russian disinformation campaigns surrounding US-supported laboratories in Ukraine, the Caucasus and Central Asia.

Preferred:

- 1) At least three (3) years of experience collaborating with various stakeholders on topics of Nonproliferation Norms and Countering Nonproliferation Disinformation.
- 2) Previous experience implementing trainings, events, and/or conferences in Asia and Europe.
