

CRDF GLOBAL REQUEST FOR PROPOSAL (RFP)

Subject Matter Experts on Strengthening Due-Diligence Practices to Disrupt Russian Procurement of ACW Technology in Machine Tools Industry

Deadline: July 29, 2024

Summary:

CRDF Global is seeking subject matter expert(s) (SMEs) with expertise in international sanctions regimes and export controls and experience in the machine tools industry and related networks which are involved in the production and sales of dual-use commercial products that may be exploited by malign actors to contribute to the Russian Federation's defense sector's procurement of Advanced Conventional Weapons (ACW) technology. The SME(s) will develop in-depth research deliverables and analysis to address sanctions evasion activities and to bolster participants' capacity to conduct due diligence and open-source investigations to counter a state proliferator's exploitation of machine tools industry. Research deliverables will be presented during two (2) separate, in-person trainings for audiences in a partner country.

Scope:

The SME will deliver two back-to-back one-day workshops in the partner country for at least 60 total (30 per training) private sector machine tools industry stakeholders and/or related association(s) on preventing proliferation of ACW supply chains through due diligence and protecting dual-use items to increase sanctions awareness and strengthen compliance processes to counter Russia's sanction evasion activities.

Tasks and Deliverables:

CRDF Global is seeking SME(s) which can implement the whole project OR a portion of the deliverables that is best suited to the SME(s) capabilities and past experience.

CRDF will consider proposals from both individuals and institutional teams which can support the following tasks and deliverables:

- 1. Aid in identification and of communications with key stakeholders throughout project term (6 months);
- Develop content for and deliver two (2) back-to-back one-day workshops in two different cities in a partner country to train at least a total of 60 participants from the machine tools companies and related associations on conducting enhanced due diligence practices to prevent inadvertent cooperation with Russian Federation's defense procurement networks (anticipated September 2024);
- 3. Attend bi-weekly and ad-hoc coordination calls as needed until end of project (no later than December 2024);
- 4. Submit an After Action Report which summarizes observations, successes, lessons learned, and recommendations for future programming based on the training.



Preferred Contractor Requirements:

- 1. At least five years of relevant experience conducting research, delivering briefings or trainings, and/or implementing policy or capacity-building activities related to counterproliferation finance or Russian Federation's defense sector.
- 2. Knowledge of the following subject matter areas:
 - a. Methods the Russian Federation's defense sector uses to facilitate and obfuscate the procurement and sale of CNC machine tools and ACW components to evade legal frameworks and sanctions.
 - Using open-source investigations and data analysis to identify individuals and companies involved in illicit Russian ACW proliferation networks involving transshipment hubs, including connections to offshore networks and corporate secretarial and management providers.
 - c. Using public records to identify corporate network data and beneficial ownership information related to defense procurement, corruption, and the arms trade.
 - d. US legal frameworks and international sanctions such as the: CAATSA-231 (d) List of Specified Persons (LSP), U.S. Department of Commerce's Military End User List and Entity List, Treasury's Specially Designated Nationals and Blocked Persons (SDN) list, and relevant executive orders.
 - e. Trends and emerging threats related to Russian sanctions evasion activities to obtain dual-use technologies, machine tooling, and microelectronic components.
- 3. Working with or advising regulatory bodies, export control agencies, law enforcement, multinational corporations, or anti-money laundering and compliance professionals to strengthen compliance programs.
- 4. Familiarity with suspicious transaction reporting and compliance processes, extensive experience in export controls and risk management, and expertise in ACW component diversion and transshipments.
- 5. Experience developing public-private partnerships.
- 6. Experience with virtual and in-person events, capacity building programs, teaching, and/or leading trainings for international audiences.
- 7. Familiarity with compliance platforms & screening tools.

- Cost proposal: Please structure as costs per deliverable and total project cost; OR include hourly rates, labor hour estimates per deliverable, and the total project cost;
- Applicable references regarding the past performance (if available);



- Any Small or Disadvantaged Business Designations (Veteran Owned, HUB Zone, Women Owned, Disadvantaged Businesses);
- NAICS Codes:
