

CRDF GLOBAL REQUEST FOR PROPOSAL

Identification and Integration of a SaaS-Based Program Management System

Deadline Extended to: January 17, 2025

Overview

CRDF Global seeks proposals from qualified vendors to assist in selecting, designing, and implementing a comprehensive Program Delivery System (PDS). The PDS will streamline project workflows, enhance collaboration, enable robust data analytics, and integrate seamlessly with existing enterprise systems, such as ERP, CRM, and productivity tools. The system must cater to CRDF Global's diverse operational needs, support scaling for future growth, and comply with federal contracting requirements.

Project Objectives

- a) Identify a flexible, scalable PDS solution tailored to CRDF Global's needs.
- b) Implement a centralized platform to:
 - o Plan, organize, and manage multiple projects and programs
 - o Consolidate and roll up information from the lowest level to the highest level.
 - o Enable efficient tracking of milestones, resource allocation, budget control, and risk management.
 - o Enhance communication across global teams and stakeholders.
- c) Ensure seamless integration with CRDF Global's existing technology stack.
- d) Provide implementation support and comprehensive change management to ensure adoption.
- e) Establish measurable Key Performance Indicators (KPIs) and tracking mechanism to evaluate system implementation and integration success.

Scope:

Phase 1, Discovery: Requirements Review and Gap Analysis

- Review CRDF Global's documented requirements and current workflows.
- Validate existing requirements and identify any critical gaps or updates needed.
- Incorporate feedback from stakeholders to ensure alignment with organizational goals.

Deliverables

- Requirements Validation and Updated Gap Analysis Report.
- Map of current workflows, processes, and systems.

Phase 2, Evaluation: Solution Evaluation and Selection

- Develop evaluation criteria based on functionality, security, scalability, and cost.
- Facilitate demos and Q&A sessions with shortlisted vendors.
- Analyze vendor proposals and recommend the most suitable solution.

Deliverables:

- Draft vendor evaluation criteria.
- Final Vendor Evaluation Matrix and Recommendation Report.

Phase 3, Design: System Design and Planning

- Collaborate with CRDF Global to design workflows, architecture, and integrations.
- Develop a phased implementation roadmap, including risk assessment and mitigation strategies.



Develop user acceptance framework.

Phase 4, Testing: Implementation and Testing

- Configure and deploy the PDS solution in a test environment.
- Integrate and migrate data and ensure compatibility with existing systems.
- Conduct iterative testing and implement user acceptance framework.

- Configured Test Environment and Data Migration Report.
- User Acceptance Framework Report

Phase 5, Deployment: Training, Go-Live, and Support

- Conduct end-user and administrator training sessions.
- Deploy the system in a production environment.
- Provide post-go-live support and documentation.

- Training Materials and Sessions for Users and Administrators.
- How To Processes.
- Go-Live Checklist and Support Plan.

Contractor Requirements:

- Experience with enterprise-level PDS implementation and SaaS solutions.
- Demonstrated expertise in integrating systems into diverse business environments, including but not limited to Deltek Costpoint and Deltek Talent Management.
- Familiarity with federal compliance standards and reporting requirements.

Proposal Requirements:

- Overview of the consulting firm and relevant project experience.
- Proposed methodology and project timeline.
- Cost breakdown, including fees and potential additional costs including a phased budget breakdown for each implementation phase (Discovery, Evaluation, Design, Testing, Deployment).
- References from similar projects.
- Provide a risk management strategy addressing data migration and system downtime.
- Detailed sustainability and scalability plans to accommodate future organizational needs.
- Define measurable Key Performance Indicators (KPIs) for implementation and post-go-live.
- Propose a detailed post-implementation support model, including issue resolution timelines and regular system updates.
- Statement of Interest and Technical Capabilities

Contractor Selection Criteria:

CRDF Global will select the contractor that provides the best value in terms of overall price and experience. The contractor should have proven experience working with (Identification and Integration of a SaaS-Based Program Management System).

Basis for Award

CRDF Global intends to issue a Time & Materials (T&M) cost reimbursable contract resulting from this RFP. Proposals received in response to this RFP will be evaluated on a best value basis. CRDF Global will evaluate both technical and price factors, weighing them to determine which offer represents the best value.

Evaluation Criteria

The evaluation criteria is as follows:

- Factor A Management and Technical Approach
- Factor B Cost/Price

Each offeror will be evaluated based on the criteria below. Factor A is significantly more important than Factor B. In the event that management and technical proposals across offerors trend towards equality, cost will become a more determinative factor in the award decision. CRDFs selection will be based upon an integrated assessment of all evaluation factors.

Evaluation Criteria Definitions

In its evaluation of the offerors management and technical approach, CRDF may identify significant strengths, strengths, significant weaknesses, weakness and deficiencies relying on the definitions below.



- **Significant Strength** An aspect of the offerors proposal that appreciably enhances the merit of the proposal or appreciably increases the probability of successful contract performance.
- **Strength** An aspect of the proposal that has merit or exceeds specified performance or capability requirements in a way that will be advantageous to CRDF during contract performance.
- Weakness A flaw in the proposal that increases the risk of unsuccessful contract performance.
- **Significant Weakness** A flaw in the proposal that appreciably increases the risk of unsuccessful contract performance.
- **Deficiency** A material failure of a proposal to meet CRDFs requirement or a combination of significant weaknesses in a proposal

Adjectival Rating and Definition

A single technical rating will be assigned for the management and technical approach of the offeror's proposal. The ratings include consideration of risks in conjunction with a proposal's significant strengths, weaknesses or deficiencies.

Numerical Rating	Adjectival Rating	Description
5	Outstanding	Proposal demonstrates an exceptional approach and understanding of the requirements and contains multiple strengths and/or at least one significant strength, and risk of unsuccessful performance is low.
4	Good	Proposal indicates a thorough approach and understanding of the requirements and contains at least one strength or significant strength, and risk of unsuccessful performance is low to moderate.
3	Acceptable	Proposal meets requirements and indicates an adequate approach and understanding of the requirements, and risk of unsuccessful performance is no worse than moderate.
2	Marginal	Proposal has not demonstrated an adequate approach and understanding of the requirements, and/or risk of unsuccessful performance is high.
1	Unacceptable	Proposal does not meet requirements of the solicitation and contains one or more deficiencies and is not awardable and/or risk of performance is unacceptable high.

Factor A - Management and Technical Approach

CRDF will evaluate the effectiveness and efficiency of the offerors approach to managing the planning and execution of the work.

- The offerors understanding of the requirements.
- The offerors experience with enterprise level PDS implementation and SaaS solutions.
- The offerors experience integrating systems into diverse business environments, including Deltek Costpoint and Deltek Talent Management.
- The offerors' ability to develop a logically sequenced schedule/timeline
- Any assumptions made by the offeror relevant to the management and technical approach

Factor B - Cost/Price

The total proposed cost/price will be evaluated for cost realism, reasonableness, and completeness.

<u>Transfer to Final Contract.</u> The terms and conditions of the RFP, including the specifications and the completed proposal, will become at CRDF Global's sole discretion, part of the final contract (the "Agreement") between CRDF Global and the selected bidder. In the event that responses to the terms and conditions will materially impair a bidder's ability to respond to the RFP, bidder should notify CRDF Global in writing of the impairment.
