

CRDF GLOBAL REQUEST FOR PROPOSAL

Deadline: Ongoing

Summary:

CRDF Global is seeking subject matter experts (SMEs) in a number of topic areas to support ongoing and future projects under the Foundational Infrastructure for Responsible Use of Small Modular Reactor Technology (FIRST) program. The FIRST program harnesses the power of the nuclear industry to engage partner countries worldwide seeking to build or expand their nuclear energy programs to meet energy needs consistent with the highest nuclear security, safety, and nonproliferation standards. Engagements under the program include but are not limited to workshops, webinars, technical consultancies, study tours, and site visits.

Scope:

SMEs will work with CRDF Global to lend subject matter expertise to support the successful delivery of FIRST program engagements, enabling partner countries to safely and responsibly develop civil nuclear energy programs leveraging small modular reactor (SMR) or other advanced reactor technologies. SMEs will work under the close operational supervision of CRDF Global to provide a variety of support including but not limited to training, presentation, resource, and/or case study material development and delivery during workshops, meetings, webinars, and/or courses; hosting study tours and/or site visits for FIRST partner country delegations; and designing and delivering pre-feasibility studies, site assessments, and/or providing other consultative services.

Specific areas where SMEs are sought to provide subject matter expertise are the following:

- Nuclear security and nonproliferation
- Nuclear safety and licensing for advanced reactors
- Site selection and characterization
- Workforce development
- Stakeholder engagement
- Preparation for SMR financing
- Understanding the role of nuclear in the energy mix
- Planning for spent fuel and waste management
- Compliance with relevant international treaties and obligations

Tasks and Deliverables:

SMEs may submit proposals in response to this RFP for any or all of the Tasks below.

Task One: Material Development for Trainings, Workshops, Webinars, and other Engagements

The Contractor will provide their subject matter expertise by developing engagement materials, such as written presentations, case studies, and leave-behind resources, which will be submitted to CRDF Global at least 10 days before the scheduled start of the engagement. The Contractor will also provide their input on documents including but not limited to engagement agendas and evaluation materials. The Contractor will participate in coordination calls and email communication as requested.

<u>Anticipated Task One Deliverables:</u>

- Materials at least 10 days prior to the start of the engagement which they are supporting.
- Input on agendas and evaluation materials for the engagement which they are supporting.
- Participation in coordination calls and email communications as requested by CRDF Global.



Task Two: Implementation of Trainings, Workshops, Webinars, and other Engagements

The Contractor will support the delivery of FIRST program engagements as requested by CRDF Global. Depending on the structure and dates of the engagement, the Contractor will serve as an expert either in-person or remotely (e.g. via webconferencing). If in-person, the Contractor will travel internationally or domestically to the site of the engagement. The Contractor will deliver materials developed on identified topics, answer participants' questions, and facilitate discussions during each engagement they are tasked to support. If in-person, the Contractor should expect to arrive one day prior to the engagement and depart the day following the engagement. If virtual, the Contractor should expect to join each session at least 30 minutes early and stay after the session for a 30-minute debrief.

Anticipated Task Two Deliverables:

- Provide subject matter expertise during FIRST engagements, either virtually or in-person, on relevant topics identified by CRDF Global.
- Deliver materials, answer questions from participants, and facilitate discussion during each FIRST engagement the Contractor is asked to support.

Task Three: Design and Delivery of Studies, Assessments, and/or Consulting.

The Contractor will provide their subject matter expertise by designing and delivering pre-feasibility studies, site assessments, and/or providing other consultative services. For studies and assessments, CRDF Global will provide the Contractor with information on the partner country(ies), company(ies), and/or site(s) of interest including contact information and other relevant direction. For consulting services, CRDF Global will provide the Contractor with the specific scope of work. If in-person travel is required, the Contractor will travel internationally to the site(s) of engagement, meetings, and/or assessments. Any written materials should be submitted to CRDF Global at least 10 days before being shared with international partners. The Contractor will participate in coordination calls and email communication as requested.

Anticipated Task Three Deliverables:

- Pre-feasibility study plan, site assessment plan, and/or consulting plan depending on the specific scope of work from CRDF Global.
- International travel if required to sites of engagement, meetings, and/or assessments.
- Materials at least 10 days prior to sharing with international partners.
- Participation in coordination calls and email communications as requested by CRDF Global.

Task Four: Reporting and Debrief

The Contractor will provide one final report following the completion of each engagement that they support. The feedback will consist of the Contractor's observations as well as suggestions for future activities with the target country. The Contractor will participate in a debrief call after the event is completed.

Anticipated Task Four Deliverables:

• One final activity report to CRDF Global following the completion of each engagement, to be received no later than 10 days after the training is completed.

- For Tasks requiring travel: the ability to travel domestically or internationally, depending on engagement.

<u>Transfer to Final Contract.</u> The terms and conditions of the RFP, including the specifications and the completed proposal, will become at CRDF Global's sole discretion, part of the final contract (the "Agreement") between CRDF Global and the selected bidder. In the event that responses to the terms and conditions will materially impair a bidder's ability to respond to the RFP, bidder should notify CRDF Global in writing of the impairment.
