

**CRDF GLOBAL  
REQUEST FOR PROPOSAL**

**Deadline: February 02, 2026**

**Summary:**

CRDF Global is seeking subject matter experts (SMEs), from academic institutions, consulting organizations, American private security companies, and other relevant organizations to support two (2) three-day regional workshops in Nairobi, Kenya and Dakar, Senegal, tentatively planned for May 2026 (Nairobi) and September 2026 (Dakar). The events will bring together participants from public and private sectors. The workshops will provide technical training on international compliance standards, risk evaluation and mitigation, and open-source investigation tools while addressing the political and economic costs of contracting illicit or unregulated PMSCs. Building on CRDF Global's extensive experience in Sub-Saharan Africa and leveraging local partners, this initiative seeks to protect U.S. interests by reducing partner vulnerability to malign influence, illicit financial flows, and resource exploitation by Russian and Chinese Private Military and Security Companies (PMSCs).

**Scope:**

CRDF Global seeks subject matter experts (SMEs) with demonstrated experience in private military and security companies (PMSCs), international compliance standards, risk evaluation, and due diligence practices. The selected SMEs will support CRDF Global in the design and delivery of two three-day regional workshops in Nairobi, Kenya and Dakar, Senegal in 2026, tentatively planned for May 2026 (Nairobi) and September 2026 (Dakar).

Working under CRDF Global's technical direction, the SMEs will develop session content, case studies, and practical tools to strengthen participants' ability to identify and mitigate the political, financial, reputational, and natural resource risks associated with engaging unregulated or illicit PMSCs linked to Russia and China. SMEs will provide training on international standards and best practices for private security and open-source investigative tools that participants can use to detect and address risks in their engagement with PMSCs and PMSC-affiliated actors.

The seeks subject matter experts (SMEs) will collaborate closely with CRDF Global, Cooperative Threat Reduction (CTR), and regional stakeholders to tailor content and interactive components to the African context. The workshops will include lectures, facilitated discussions, and case studies focused on understanding PMSC operational risks, compliance challenges, and mitigation strategies.

**Intended Outcomes**

By the end of this program, participants will possess:

- Increased awareness of the political, financial, reputational, and natural resource risks associated with engaging illicit or unregulated PMSCs.
- Strengthened capacity to identify and counter PMSC-linked proliferation activities and associated security risks.

- Practical skills in the use of open-source investigative tools and international due diligence best practices to investigate connections to illicit PMSCs and PMSC-affiliated actors.
- Increased understanding of international standards governing PMSCs, including how to evaluate adherence to these standards when working with private security partners, and awareness of best practices demonstrated by American private security companies.

#### **Tasks and Deliverables:**

*The contractor will be responsible for completing the below tasks for each workshop, with additional details added based on the specific scope of the activity.*

##### **Task One: Developing Conference Agendas**

The contractor will participate in a kick-off meeting with CRDF Global to review project objectives, clarify expectations, and coordinate roles. Following the meeting, the contractor will develop detailed agendas for the two three-day regional workshops in Nairobi, Kenya and Dakar, Senega, , tentatively planned for May 2026 (Nairobi) and September 2026 (Dakar). Agendas should include session sequencing, technical content, and case studies aligned with the project's focus on PMSC-related risks, compliance, and mitigation strategies.

##### Task One Deliverables:

- Develop and submit complete draft and final agendas for both workshops, including session sequencing, technical content, and case studies.

##### **Task Two: Contributing to Development of Conference Materials**

The contractor will develop all technical materials required for the workshops, including presentations, case studies, reference materials, and handouts. Materials should reinforce the agenda content and focus on international standards for PMSCs, risk evaluation, due diligence tools, and mitigation strategies.

##### Task Two Deliverables:

- Develop all conference materials, including presentations, case studies, reference materials, and handouts
- Submit final conference materials to CRDF Global for review and approval.

##### **Task Three: Delivery of Conferences and Consultations**

The contractor will travel to Nairobi and Dakar, tentatively planned for May 2026 (Nairobi) and September 2026 (Dakar), to deliver the sessions outlined in the approved agendas for the two (2) three-day regional workshops. The contractor will coordinate closely with CRDF Global to ensure smooth integration of their presentations, and case studies

CRDF Global will provide all travel arrangements to and from each conference location, including airfare, lodging, airport transfers, per diem in accordance with U.S. Department of State rates, and travel medical insurance.

*Task Three Deliverables:*

- Deliver all assigned presentations and materials during the two (2) three-day regional workshops in Nairobi, Kenya and Dakar, Senega, tentatively planned for May 2026 (Nairobi) and September 2026 (Dakar).
- Active participation in discussions and case study exercises during the workshops

**Task Four: Conference Close-out, Reporting and Evaluation**

The contractor will complete and submit to CRDF Global an after-action report summarizing the technical outcomes of the conferences, including activity successes, key observations, participant feedback, and recommended areas for future programming. The report should reflect insights from both conferences in Nairobi, Kenya and Dakar, Senegal.

*Task Four Deliverables:*

- Submit an after-action report summarizing the technical outcomes, outlining activity successes, key observations, participant feedback, course feedback, and recommended areas for future programming.

**Contractor Requirements:**

CRDF Global is seeking qualified contractors, including academic institutions, consulting organizations, American private security companies, and other relevant organizations, with demonstrated subject matter expertise in private military and security companies (PMSCs), international compliance standards, risk evaluation, and due diligence practices.

Contractors should have proven experience designing and delivering in-person training or capacity-building workshops for public- and private-sector stakeholders, preferably in Sub-Saharan Africa or comparable operating environments. Contractors must demonstrate familiarity with international standards and best practices for private security, open-source investigative tools, and the political, financial, legal, and security risks posed by illicit or unregulated PMSCs.

Strong written and oral communication skills in English are required. Experience working with government counterparts, international organizations, or donor-funded programs is strongly preferred.

Evaluations will be based on CRDF Global's assessment of the Contractor's ability to meet CRDF Global's key requirements, including competitive pricing, quality of the proposal, past performance, and other intangible factors. CRDF Global reserves the right to accept or reject any or all proposals and to negotiate the terms of any subsequent agreements at its own discretion.
