

**CRDF GLOBAL**  
**REQUEST FOR PROPOSAL**

**Deadline: *February 13, 2026***

**Summary:**

CRDF Global is seeking an open-source subject matter expert (SME) to conduct research and develop tailored technical materials for an upcoming chemical security technical briefing tour in Europe, which will include countries such as Germany, Switzerland, and Czechia. On behalf of the U.S. Department of State's Office of Cooperative Threat Reduction (CTR), CRDF Global will subcontract an SME to provide expert analysis and materials that strengthen European partners' understanding of proliferation-sensitive activities and improve government and industry oversight of chemical supply chains vulnerable to exploitation by state chemical weapons (CW) procurement networks.

**Scope:**

The subject matter expert (SME), hereby referred to as "The Contractor," will conduct open-source research and prepare tailored, country-specific technical materials in support of CRDF Global's upcoming engagement titled, "Preventing Chemical Precursor Exploitation in Western Europe Through Technical Briefings and Regional Summits".

The Contractor will conduct open-source research on supply chain threats that Europe is facing from Iran, focusing on state-directed efforts to acquire CW-relevant materials, equipment, and expertise through illicit procurement networks. The Contractor will analyze how these activities exploit legitimate commercial trade channels in the chemical, pharmaceutical, and dual-use equipment sectors, and identify typologies, front company structures, and red flags indicative of proliferation-sensitive transactions.

The Contractor will be awarded a contract based on the completion and submission of the following tasks and deliverables:

**Tasks and Deliverables:**

**Task One: Project Coordination and Communication**

In coordination with the CRDF Global project team, the Contractor will actively participate in all scheduled coordination meetings and maintain regular communication via email and other designated channels. The Contractor will provide timely updates on progress, address requests for clarification, and coordinate closely with CRDF Global to ensure alignment on research objectives, deliverable expectations, and deadlines.

**Task One Deliverables:**

- Attendance at all scheduled coordination meetings with CRDF Global and/or CTR representatives.

**Task One Level of Effort:**

- One monthly meeting with CRDF and/or CTR for data check-ins.
- One meeting to review and provide feedback on the draft product for CTR.
- One final meeting to review the completed product with CTR and CRDF staff.

**Task Two: Open-Source Research and Analysis**

In coordination with the CRDF Global project team, the Contractor will conduct open-source research and analysis to create a comprehensive report which will include:

- Iranian-linked procurement efforts targeting European chemical and pharmaceutical supply chains, including front companies.
- Identification of indicators of suspicious procurement activities, sensitive precursors and dual-use equipment, and emerging proliferation trends.
- Document relevant vulnerabilities within European trade and regulatory systems being exploited by proliferator networks.
- Assessment of country-specific risk factors relevant to Germany, Switzerland, Finland, and Czechia.

During the inception phase, the Contractor will work with CRDF Global to refine specific research questions and analytical lines of effort within this overall scope, ensuring that final outputs align with available data sources, analytical capabilities, and stakeholder needs.

To ensure methodological rigor and transparency, the Contractor should clearly outline the analytical approach, data sources, and tools used in conducting open-source research. Proposals should describe:

- The open-source or commercial datasets, databases, and screening tools that will be used (e.g., trade databases, corporate registries, sanctions lists, scientific publications).
- Any existing dual-use screening methodologies or frameworks that will be applied or adapted.
- How the research will ensure replicability, transparency, and compliance with export control and data protection regulations.

Preference may be given to applicants who can leverage or adapt proven dual-use screening methodologies and data analysis tools for use in the European context.

**Task Two Deliverables:**

- One open-source research report meeting the agreed-on requirements.
- Supporting materials (e.g., charts, typology summaries, or red flag matrices) suitable for use in government and industry technical briefings.

**Task Two Level of Effort:**

- Not to exceed **X hours** without written approval from the CRDF Global Agreement Officer.

**Contractor Requirements:**

The Contractor will have experience conducting open-source research and developing technical materials related to chemical security, nonproliferation, and supply chain risk analysis. The Contractor should have expertise in identifying and analyzing proliferation-sensitive procurement pathways, dual-use chemicals and equipment, and front company networks supporting state-directed chemical weapons (CW) programs.

The Contractor should also demonstrate familiarity with common open-source and commercial datasets used in dual-use screening and proliferation analysis (e.g., trade data platforms, customs records, sanctions lists, scientific databases, or business registries) and an ability to integrate multiple data streams into actionable analysis.

The Contractor should have prior experience supporting government or international programs focused on chemical nonproliferation, export controls, or supply chain integrity, preferably within the European or broader international context. Experience producing analytical reports, red flag indicators, and tailored risk assessments for both government and industry audiences is highly desirable.

Proposals that demonstrate a tested analytical methodology or proprietary screening framework, as well as prior success in detecting or mapping proliferation-linked procurement behavior, will be considered favorably.

The Contractor will have demonstrated capability in one or more of the following technical areas:

- Open-source research and analysis of Iranian-CW procurement networks
- Identification of dual-use chemicals, precursors, and production equipment relevant to PBA or CW agent synthesis
- Application or adaptation of dual-use screening methodologies and data-driven tools to identify proliferation risks in European supply chains
- Know Your Customer (KYC) and customer due diligence practices for the chemical and pharmaceutical industries
- Analysis of trade and transport vulnerabilities in hazardous chemical supply chains
- Detection of red flags and typologies of high-risk or front companies
- Assessment of state-linked proliferation networks (e.g., Iranian procurement activities in Europe)
- Development of country-specific technical materials and risk communication products for government and industry stakeholders

### **Subject Matter Experts shall have:**

1. Technical Experience: At least 7-10 years of relevant professional experience. Applicable experience can include a combination of the below:
  - a. Knowledge of chemical security and chemical weapons nonproliferation, including familiarity with relevant international frameworks, key threat actors, and proliferation trends in Europe.
  - b. Experience conducting open-source research and analysis related to chemical procurement networks, front companies, and dual-use supply chain vulnerabilities.
  - c. Experience educating on PBA precursors, dual-use chemicals, and production equipment relevant to CW proliferation activities.
  - d. Experience consulting on regulatory and voluntary initiatives to prevent chemical precursor acquisition.
  - e. Knowledge of chemical transportation security, including vulnerabilities and mitigation measures within transnational logistics and distribution networks.
  - f. Experience developing analytical materials or interactive case studies that support government and industry awareness of suspicious procurement patterns, red flags, and compliance best practices.

Experience engaging international audiences including policymakers, government, and regulators, and/or industry leaders in Europe.
