**REQUEST FOR INFORMATION or QUOTE or PROPOSAL**

**Deadline: *February 16, 2026***

**Summary:**

CRDF Global seeks qualified subject matter experts (SMEs) from consulting firms, maritime compliance and risk advisory organizations, logistics and shipping advisory entities, and other relevant organizations to support the design and delivery of a series of five (5) one-day, in-person workshops focused on identifying, assessing, and mitigating Russian sanctions-evasion activities in the maritime and related logistics sectors. The workshops are tentatively planned to be conducted in Greece, Türkiye, Brazil, Singapore, and one additional partner country to be identified.

Each workshop will convene approximately 30 participants drawn from maritime authorities, port administrations, flag registries, shipping and logistics operators, insurers and reinsurers, classification societies, and other relevant public- and private-sector stakeholders. The workshops will provide applied, scenario-based training designed to strengthen compliance with U.S. sanctions regimes by improving participants' ability to identify high-risk Russian-linked vessels and transactions; detect deceptive and obfuscation practices, including vessel identity and flag changes, AIS manipulation, and illicit ship-to-ship transfers; and analyze commercial shipping and logistics documentation to support risk-based decision-making and enforcement actions.

**Scope:**

CRDF Global seeks subject matter experts (SMEs) with demonstrated expertise in U.S. maritime sanctions implementation, shipping and logistics compliance, risk management, and investigative due diligence. Selected SMEs will support CRDF Global in the design and delivery of five (5) one-day, in-person workshops delivered across multiple regions, beginning with proposed engagements in Greece and Türkiye.

Working under CRDF Global's technical direction, SMEs will develop session content, case studies, and practical tools to strengthen participants' ability to identify and respond to Russian maritime sanctions-evasion activities. This includes identification of high-risk Russian-linked vessels and transactions; detection of dark fleet behavior, illicit ship-to-ship transfers, AIS manipulation, and vessel identity or flag changes; and assessment of compliance and enforcement risks associated with non-compliance with U.S. sanctions.

SMEs will provide training on U.S. sanctions frameworks and applicable regulatory requirements, as well as, where relevant, complementary international regimes; maritime domain awareness tools; vessel-tracking and risk-profiling methodologies; and analysis of commercial shipping and logistics documentation, including manifests and bills of lading. SMEs will collaborate closely with CRDF Global, the Office of Cooperative Threat Reduction (CTR), and regional stakeholders to tailor content to local operational and regulatory contexts.

**Intended Outcomes**

By the end of this program, participants will possess:

- Enhanced ability to identify and assess Russian maritime sanctions-evasion activities.
- Strengthened due-diligence, compliance, and investigative decision-making across the maritime and logistics sectors.

- Improved understanding of obfuscation tactics, high-risk vessels, and deceptive shipping practices.
- Increased capacity for information-sharing and coordination among government authorities and private-sector stakeholders.

**Tasks and Deliverables:**

*The contractor will be responsible for completing the below tasks for each workshop, with additional details added based on the specific scope of the activity.*

**Task One: Developing Workshop Agendas**

The Contractor shall participate in an initial kick-off meeting with CRDF Global to review program objectives, clarify technical expectations, and coordinate roles and responsibilities. Following the kick-off meeting, the Contractor shall develop detailed agendas for five (5) one-day, in-person workshops. Agendas shall define session sequencing, instructional objectives, and technical content, and shall incorporate applied case studies aligned with U.S. maritime sanctions compliance and enforcement, maritime risk indicators, and sanctions-evasion mitigation strategies.

**Task One Deliverables:**

- Draft and final agendas for all five (5) workshops, submitted to CRDF Global for review and approval.

**Task Two: Contributing to Development of Workshop Materials**

The Contractor shall develop all technical and instructional materials required for delivery of the workshops. Materials shall include, as appropriate, slide presentations, applied case studies, practical exercises, reference documents, and participant handouts. Content shall focus on U.S. sanctions frameworks, maritime sanctions-evasion typologies, vessel-tracking and detection methodologies, analysis of commercial shipping and logistics documentation, and due-diligence and compliance best practices relevant to maritime and port operations. All materials shall be submitted to CRDF Global in advance of each workshop for technical review and approval.

**Task Two Deliverables:**

- Complete set of workshop materials, including presentations, case studies, practical exercises, reference materials, and participant handouts.
- Final, CRDF Global-approved versions of all workshop materials.

**Task Three: Delivery of Workshops**

The Contractor shall travel to designated partner countries to deliver the sessions outlined in the CRDF Global-approved agendas for five (5) one-day, in-person workshops, beginning with proposed engagements in Greece and Türkiye. The Contractor shall coordinate closely with CRDF Global to ensure effective integration of presentations, case studies, and interactive exercises across all workshops.

CRDF Global shall arrange and cover all Contractor travel logistics to and from each workshop location, including airfare, lodging, airport transfers, per diem in accordance with U.S. Department of State rates, and travel medical insurance.

**Task Three Deliverables:**

- Deliver all assigned presentations and CRDF Global-approved materials during five (5) one-day, in-person workshops, beginning with proposed engagements in Greece and Türkiye.

- Actively facilitate and participate in workshop discussions and applied case study exercises in accordance with approved agendas and instructional objectives.

**Task Four: Workshop Close-out, Reporting and Evaluation**

The Contractor shall prepare and submit to CRDF Global an after-action report summarizing the technical outcomes of the five (5) workshops. The report shall synthesize observations across all engagements and document key outcomes, including instructional effectiveness, participant engagement, substantive findings related to Russian maritime sanctions-evasion risks, and lessons learned. The report should also incorporate participant feedback and identify recommended areas for future programming or capacity-building activities.

***Task Four Deliverables:***

- One consolidated after-action report summarizing technical outcomes across all workshops, including activity successes, key observations, participant and course feedback, and recommendations for future programming.

**Contractor Requirements:**

CRDF Global seeks qualified contractors, including academic institutions, consulting organizations, maritime compliance and risk advisory firms, and other relevant entities, with demonstrated expertise in maritime sanctions implementation, shipping and logistics compliance, risk evaluation, and investigative due diligence.

Contractors must demonstrate prior experience designing and delivering in-person training or capacity-building workshops for maritime authorities and private-sector stakeholders. Required competencies include working knowledge of U.S. and international sanctions frameworks, vessel-tracking and maritime domain awareness systems, analysis of commercial shipping and logistics documentation, and risk-based enforcement and compliance decision-making. Strong written and oral communication skills in English are required. Experience working with government counterparts, multilateral institutions, or donor-funded programs is strongly preferred.
